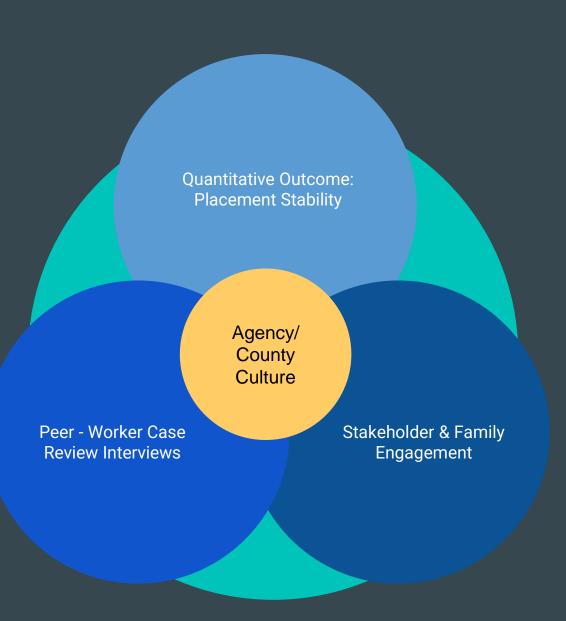
### **Placement Probation Findings**

### What You Need to Know

Successes:

- Pilot virtual engagement works!
- Provides people the opportunity to describe the lived experience
- People are not just numbers
- Leveraged technology in new ways
- Developed framework for qualitative data collection
